**AN ORDINANCE TO ESTABLISH ALL BAYOU LA BATRE  
PARKING OFFENSES TO BE ENFORCED BY THE ISSUANCE OF A  
MUNICIPAL OFFENSE PARKING CITATION PROSCRIBED FORM  
AND SCHEDULE OF FINES**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAYOU LA  
BATRE, ALABAMA as follows:**

**SECTION I:**

A violation of any existing City of Bayou La Batre parking ordinance, as may be amended from time to time, shall be punishable by the issuance of a municipal offense parking citation.

**SECTION II:**

A violation of any existing City of Bayou La Batre parking ordinance is hereby established by the City of Bayou La Batre, Alabama pursuant to the laws of the State of Alabama and the Alabama Rules of Judicial Administration. A Defendant, in lieu of appearing before the Court to contest the issuance of such citation, may deliver the scheduled amount of the fine to the Municipal Court Clerk of the City of Bayou La Batre or mail the scheduled amount to the Municipal Court Clerk at 13765 South Wintzell Avenue, Bayou La Batre, Alabama 36509 within ten (10) days of issuance of the citation.

**SECTION III:**

The scheduled of violations shall include the following fines for the following offenses:

improper parking	\$50.00
restricted parking	\$50.00
no parking zone	\$50.00
parking on side walk	\$50.00
blocking driveway	\$50.00
parking in a fire lane	\$150.00
parking in a handicapped zone	\$150.00
parking truck in residential zone	\$75.00
parking in a right-of-way zone	\$75.00
double parking	\$25.00
other improper parking	\$75.00

**SECTION IV:**

A court summons may be issued and a late fee of twenty-five (\$25.00) and No/100 Dollars assessed after ten (10) days if payment has not been received or the person cited has not appeared in person with their ticket at the Municipal Court Office for court date assignment. If payment has not been received within twenty-five (25) days of the issuance of the citation, a court summons will be issued.

**SECTION V:**

The City of Bayou La Batre Municipal Offense Parking Citation shall be on a form substantially as follows: **SEE ATTACHED EXHIBIT "A"**

**SECTION VI:**

The sections, paragraphs, sentences, clauses and phrases of this Code are severable, and if any phrase, clause, sentence, paragraph or section of this Code shall be declared unconstitutional by a court of competent jurisdiction, then such ruling shall not affect any other paragraphs and sections, since the same would have been enacted by the city council without the incorporation of any such unconstitutional phrase, clause, sentence, paragraph or section.

**SECTION VII:**


Any ordinance or parts of ordinances heretofore adopted by the City Council of the City of Bayou La Batre that are inconsistent with the provision of this Ordinance are hereby repealed.

**SECTION VIII:**

This Ordinance shall take effect and be in force from and after the date of its approval by the City Council of the City of Bayou La Batre, Alabama and publication as required by law.
