**AN ORDINANCE TO ANNEX PROPERTY CONTIGUOUS TO THE
CORPORATE LIMITS OF THE CITY OF BAYOU LA BATRE**

WHEREAS, on the 24th day of June, 2003 the Independent Church of God, being the owner of that certain parcel of real property hereinafter described, did file with the City Clerk a petition asking that the said tract or parcel of real property be annexed to and become part of the City of Bayou La Batre, Alabama; and

WHEREAS, said petition did contain the signatures of the Board of Directors as representatives of the owners of the described territory and a map of said property showing its relationship to the corporate limits of the City of Bayou La Batre, Alabama; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed into the city limits of the City of Bayou La Batre, Alabama and it did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama, 1975 as amended;

NOW, THEREFORE, BE IT ORDAINED BY MAYOR AND CITY COUNCIL OF THE CITY OF BAYOU LA BATRE, ALABAMA, AS FOLLOWS:

SECTION ONE: ANNEXATION

The City Council of the City of Bayou La Batre, Alabama finds that and declares as the legislative body of the City of Bayou La Batre, Alabama that it is in the best interests of the citizens of the City of Bayou La Batre, Alabama and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the City of Bayou La Batre, Alabama.

SECTION II. DESCRIPTION OF TERRITORY

The boundary lines of the City of Bayou La Batre, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory heretobefore encompassed by the corporate limits of the City of Bayou La Batre, Alabama and in addition thereto the following described territory, to-wit:

Commencing at the northwest corner of Section 24 Township 7 South R3W thence South 1208 feet to point of beginning thence continue South 98 feet thence East 201.73 feet thence Northeasterly along Padgett Switch Road 85.85 feet thence Northwesterly 257.07 to point of beginning Section 24 Township 7 South R#W MP44 06 24 2 000

SECTION III. PUBLICATION

This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the Independent Church of God shall be filed with the Probate Judge of Mobile County, Alabama.

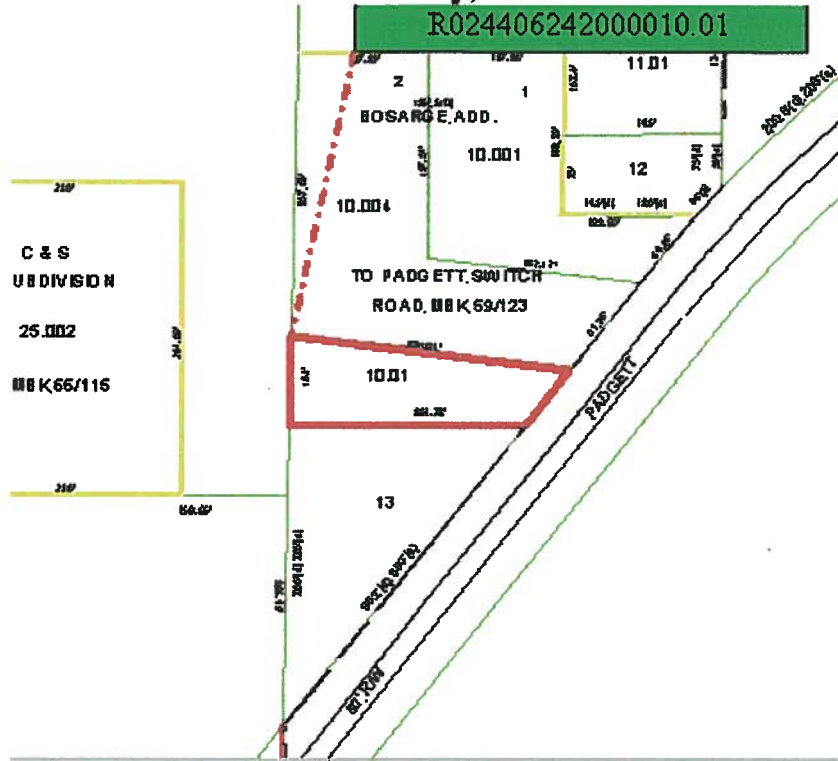
