**ORDINANCE NO.: 2003-489** 

AN ORDINANCE TO ESTABLISH CITY OF BAYOU LA BATRE FIRE CHIEF WITH AUTHORITY AS A CODE ENFORCEMENT OFFICER FOR THE CITY OF BAYOU LA BATRE

WHEREAS, the City Council of the City of Bayou La Batre has previously employed a Fire Chief and pursuant to City ordinances as well as State law, is charged with the responsibility of enforcing state statute and local ordinance related to fire safety and inspection within the City of Bayou La Batre and its police jurisdiction and;

WHEREAS, the City Council of the City of Bayou La Batre has determined that the Fire Chief for the City of Bayou La Batre, should be vested and designated as the Code Enforcement Officer for the proper, efficient and effective performance of his responsibilities commensurate with the position of Fire Chief.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BAYOU LA BATRE, ALABAMA AS FOLLOWS:

# SECTION ONE:

That the Fire Chief be and is hereby designated as a Code Enforcement Officer for the City of Bayou La Batre for purposes of enforcing all City ordinances and other state and local laws applicable for the City and the Police jurisdiction of the furtherance and performance of his position.

# **SECTION TWO:**

The provisions of this Ordinance are severable. If any provision, section, paragraph, sentence or other part thereof shall be held unconstitutional or invalid, such decision shall not affect or impair the remainder of this ordinance it being the legislative intent to ordain and enact each provision, section, paragraph, sentence or part thereof separately and independently of each other.

#### **SECTION THREE:**

All city ordinances or parts thereof in conflict with the provisions of this ordinance including Ordinance 2003-483, insofar as a conflict are hereby repealed.

#### **SECTION FOUR:**

This ordinance shall take effect and be in force from and after the date of its approval by the City Council of the City of Bayou La Batre and publication as required by law.
